SUBJECT: Transfer of General Education Core for Students with an Associate or Baccalaureate

Degree

Background: This policy defines how transfer students with a Baccalaureate or Associate degree will receive equated credit for general education core (including GEM curricula) as part of a transparent and seamless transfer experience.

Policy includes: The Statewide General Education Policy, Board Policy III.N, Statewide General Education, outlines Idaho's General Education Framework and establishes guidelines for General Education Matriculated (GEM – See figure 1) curricula across all public postsecondary institutions.

A. Academic Undergraduate Degrees

- 1. Students who complete requirements for the Associate of Arts or Associate of Science degree at a regionally accredited postsecondary institution in Idaho will be considered as satisfying the general education requirement, as defined in Board Policy III.N., upon transfer to Lewis-Clark State College and will not be required to complete any additional general education requirements; unless a specific general education class is required to meet a specific program requirement.
- 2. Students who have completed the 30-credit General Education Framework, as defined in Board Policy III.N, without an Associate of Arts or Associate of Science Degree and transfer from a regionally accredited postsecondary institution in Idaho, may be required to complete 6 additional "institutionally defined" general education requirements at Lewis-Clark State College.
- 3. If a student has completed a GEM course(s) but has not completed the entire General Education Framework or an Associate of Arts or Associate of Science Degree, those GEM courses will be applied towards the associated GEM competency requirements at Lewis-Clark State College.
- 4. Students transferring with an earned Bachelor of Arts, Bachelor of Science, Associate of Arts, or Associate of Science degree from a regionally or nationally faith-based accredited institution in Idaho or Treasure Valley Community College have met the LCSC general education core requirements.

SUBJECT: Transfer of General Education Core for Students with an Associate or Baccalaureate Degree

- 5. Students transferring from any regionally accredited institution within the United States who have completed the equivalent of the Idaho State Board of Education's general education core either with an AA, AS, or AAS, or have their transcript noted "Core Certified" will be assessed on an individual basis. If core requirements have been met, they will be identified as "core complete." If three or more core components are absent, the student will be required to complete the necessary core coursework in order to meet LCSC's General Education Core requirements, unless a specific articulation agreement approved by both institutions states otherwise.
- 6. Completion of General Education with courses transferred from other institutions does not necessarily mean that program specific core requirements have been satisfied. Students must work closely with advisors to ensure that all core specific program requirements are met.
- 7. International students who transfer in four-year BA or BS degrees from their home country will be reviewed on an individual basis. Generally Core completion is NOT granted due to English language requirements.
- B. Associate of Applied Science (AAS) Degrees
 - 1. If a student satisfactorily completes a GEM course(s) as part of the Associate of Applied Science (AAS) degree and then subsequently transfers to Lewis-Clark State College, those GEM courses will be applied towards the associated GEM competency at LCSC.
 - 2. A student who completes an AAS degree may pursue an interdisciplinary Bachelor of Applied Science or a Bachelor of Applied Technology degree focused on upper-level academic coursework.
 - 3. Associate Degrees in Nursing (ADN), Associate of Applied Science or Associate of Applied Technology degrees typically do not meet the requirements for the General Education and will be reviewed on an individual basis.
 - 4. Completion of General Education with courses transferred from other institutions does not necessarily mean that program specific core requirements have been satisfied. Students must work closely with advisors to ensure that all core specific program requirements are met.
 - 5. Core completion will be awarded at the discretion of the transcript evaluator in the Registrar & Records Office, with input from the Division Chairs.
