Non-Profit Spaces (10'x10') may sell raffle tickets, posters or any merchandise, other than food, while distributing their information. The sale of food or drinks is prohibited in the Family Fun Fair; if your organization is interested in selling food, water or other beverages please submit a Non-Profit Food Vendor Application.

DOES AUE PROVIDE SECURITY?

HOW DO I CHECK IN, SET-UP & TAKE DOWN MY BOOTH?

Check-In is required at the Admission Booth in front of the Administration Building prior to booth assignment. Family Fun Fair Non-Profit set up is on Friday, April 24; 9:00 a.m.—11:00 a.m. Take-down begins at 4:00 p.m. on Sunday, April 26. Vendors will receive 1 AUE Loading Pass to the loading/unloading area to unload inventory and materials for a maximum of 1 hour during check-in. vendors must provide any equipment needed for set-up/take-down of their booth.

WHAT CAMPUS RULES APPLY AT AUE?
