Dear all,

As we ramp up for the semester and prepare to bring students back on campus, I wanted to share some updates. It is my hope to empower staff and faculty who encounter students and families these next few days with accurate information. As you may be aware, led by our outstanding admissions and advising folks, we held a summer Destination LC pre-orientation event, and last week (Aug. 9) New Student Orientation for transfer and non-traditional students took place in the Williams Conference Center (Be sure to check out the new carpet in that venue – it not only looks great, but no longer features loose carpet bumps and ripples). Beginning this week we have student leader orientations for ASLCSC, WEB, Residence Life, and Peer Mentors; a Coeur d'Alene new student orientation in CDA, and student move-in day (Wednesday, Aug. 16), followed by Convocation, all-campus student orientation activities, lunches and receptions on Friday. The activity is ramping up!

In terms of student housing, we continue to be delayed (because of circumstances beyond our control) in opening up the Living Learning Center (LLC) (former Music building on 11th Avenue). Additionally, we still have a few repairs underway in some facilities, largely as a result of the summer flooding the LC valley experienced in June. Because of this, as well as high demand for on-campus housing (a good problem to have), we estimate we will have nearly 50 students starting the semester living at the Hells Canyon Grand Hotel (we have again reserved the Seaport wing). Approximately 30 of these students will be able to move into residences once facility repairs are complete (we anticipate this to be two-three weeks). About 20 have been placed there because, without the ability to occupy the LLC (which we anticipate will be able to house about 20 students) we are at capacity in our residence halls and rental houses. These students are comprised of student-athletes (a group who has a built-in support system through their coaches and teammates), as well as those who applied for housing late and confirmed having reliable transportation. To support students who will be living in the Hells Canyon Grand we have hired a resident assistant who will be on-site to provide programming and general support. (We did not have a resident assistant at the hotel last year). We have also garnered permission to hang an LC Banner and various LC branded artifacts on their floor and in the rooms to help them feel more associated with the college campus. Hells Canyon Grand resident students will have access to the hotel's swimming pool and hot tub, have weekly housekeeping, and we are putting together small welcome baskets. We will also be arranging a shuttle service with our campus vans for some of our campus events (we did attempt a more regular shuttle service last fall, but the service was not used). Parents of the freshmen staying at the Hells Canyon Grand have been contacted routinely by Residence Life staff. The response has been largely positive with both parents and students grateful to have housing accommodations and expressing appreciation for the extra efforts we are making. As vacancies come open in our residence halls, students will be moved back to campus. Our residence assistant will remain on-site until the last student has moved back to campus. We are doing all we can to accommodate our students and ask that you be positive ambassadors and information conduits.

Finally, this week is forecast to be hot, hot, hot. We have worked to put accommodations in place for students, staff and faculty. Where needed, we're providing fans, extra bottled water, and are arranging for the Student Union Building/Center for Student Leadership to have extended hours during the first few weeks of the semester so that students can study and relax in a cooler location. There are, however, few good options for some of our residential facilities. While it is part of our campus master plan to address vintage facility needs, central HVAC (in residence halls like Talkington) is not an option at this time. Please be assured we are doing all we can to create a welcoming, safe, and comfortable living-learning environment for our campus community.

The semester is starting and we are ready and excited. Go Warriors!



- HR Updates:
 - Employee Compliance Training: During the week of July 31, all benefit-eligible faculty and staff received a personalized email from <u>VectorSolutions</u> containing the compliance tutorials they must complete by Oct. 31. Please check your Clutter or Junk email if you did not receive this email in your inbox. As a reminder, usernames consist of your first initial, middle initial, and last name (Ex: vjswift).  - Mini Open Enrollment: An open enrollment period will be held Aug. 14-21 through Luma for anyone who would like to make changes to their medical or dental coverage. No action is required. New coverage will be effective Sept. 1, and dropped coverage will end Aug. 31. You will not receive new ID cards if you are only changing the dependents covered. During the "mini open enrollment" you will be able to:
 - Add medical or dental coverage; you may not enroll for both.
 - Remove medical or dental coverage; you may not disenroll for both.
 - Change the mix of dependents covered on your medical and/or dental. The individuals enrolled in medical and dental no longer must be the same.
- Intranet: LC State has transitioned to a new intranet solution using Microsoft Teams. The old
 intranet will soon be taken offline, so please discontinue use of it. Instead, all of campus is invited
 and encouraged to share information, have conversations, and stay informed through the new
 intranet on Teams. Conversations can be from casual to emergency related and everything in

- **Parking on Aug. 16:** Wednesday, Aug. 16, is move-in day for new residence hall students. To help students and their families park closer to Talkington Hall, Clark Hall, and College Place to unload, LC State faculty and staff are asked to avoid parking near these buildings on this day.
- **Parking Permits:** 2023-2024 parking permits are available and ready for <u>purchase online</u>. Please allow up to 48 hours after your purchase to pick up your permit at the Public Safety office, MLH 110, anytime between 7:30 a.m.-4 p.m., Monday-Friday. Ticketing will begin Monday, Aug. 28.

- Sodexo Marketplace: This fall, the SUB Marketplace will be switching to an "All You Care to Eat" at lunch (as done for breakfast and dinner). A la carte options will no longer be available. Customers can either use a meal swipe or pay the door price. Some a la carte options will be available in Jitterz. Also, to-go containers will no longer be available in the Marketplace.
