## **Monday Message**

Sept. 18, 2023



Dear all.

Last week's news article regarding college and university budget submissions was misleading. The following attempts to clarify the budget process and share information specific to LC State's submission.

Annually, beginning late spring/early summer, colleges and universities begin preparing for the next fiscal year's budget submission. The Office of the State Board of Education (OSBE), in coordination with the Idaho Department of Financial Management (DFM) sends request parameter guidelines to the institutions. Using those guidelines we prepare a budget submission that is then transmitted, via state portal, to and through OSBE to DFM to be considered.

Last year, as you may recall, colleges and universities were able to put forward a flexible occupancy enhancement request based on a percentage of past general fund appropriations (i.e., 3%). The idea being this broad category would allow discretionary flexibility. This turned out to be especially helpful to LC State as we ended up needing to allocate nearly all of this funding to meet GLBA Safeguards Rule requirements – which are associated with data security and our ability to protect Federal Student Aid applicant information.

Again, this year, the budget guidelines delimited the relative amount we could request; and directed as follows: "...DFM issued a memo on May 26, 2023, providing guidance for the FY 2025 budget requests. The memo limits FY 2025 ongoing general fund budget requests to no more than 3% above the FY 2024 ongoing general fund appropriation. The 3% must include all maintenance items, CEC and EWA for the colleges and universities." Request narratives were to be framed as an occupancy enhancement, with the added caveat that we identify <u>potential</u> areas of spending priority should the request be supported through the Governor's budget recommendation and Legislative process. LC State identified its potential priorities as excerpted below from our submission:

"The intended use of these operational capacity funds, though emerging needs may lead to a reprioritization of these funds, is to recruit and retain students by keeping student tuition low through support for marketing efforts [\$60,868], base operational inflationary costs [\$100,000], occupancy costs for a legislatively funded building [\$107,860 – note: Funding for costs associated with occupancy of the Schweitzer CTE building (e.g., utilities, custodial, grounds maintenance, etc.) were originally estimated based on a state occupancy cost formula. After the building was being constructed, support for the formula was altered and only half the originally anticipated calculation funded. LC State used a prior line-item submission to fill in some of the occupancy/operations funding gap. This request rounds out the final amount needed to fully meet the costs associated with building operation and maintenance.], and the ability to address, in part, a potential funding gap in CEC and benefits, so as to minimize impact on tuition [\$171,440 – these funds could be used to support custodial/maintenance FTE for the Schweitzer CTE building, and offset a possible CEC gap1."

It is my hope that this information helps clarify what actually has transpired to date. As was noted accurately at the conclusion of the article, the process is long, with many hurdles yet to clear. Be assured we will keep you updated as we move through the year.
