### **Course Description:**

This course is designed to provide a framework of critical thinking skills to apply to a variety of real-world scenarios. Knowledge gained and skills learned in earlier classes will be practiced and refined further with regard to communication, group work, research and critical thinking. Successful completion of this course will prepare students for today's competitive business environment and global marketplace.

### **Course Objectives:**

- 1. Develop self-awareness and application of critical thinking and decision making skills
- 2. Promote an understanding and appreciation of team development and group collaboration
- 3. Utilize technology to plan, develop and deliver an oral presentation with visual aids
- 4. Discuss, analyze and defend arguments orally and in writing
- 5. Further refine students' abilities to conduct library research and identify credible sources
- 6. Prepare students to be successful in BUS 498B Senior Seminar II

### **Professor Expectations:**

- ✓ Proper citation/referencing when not your original work (APA style required)
- ✓ Full reading of each assigned chapter in our textbook

### Method of Evaluation:

### Individual and Group Oral Reflections:

This component of your grade will consist of five, two minute impromptu "in front of the class" presentations per student throughout the course of the semester. Specific questions will be posed to students based on class discussions. Names of presenters will be "drawn" during each class period. Students whose names are drawn and are absent may not recover lost points. These presentations will be 15% of your final grade.

### Case Study:

The case study is an introduction to critical and strategic thinking material we will discuss throughout the semester and is worth 5% of your final grade.

### Library Research Mini Projects:

Two library mini projects (associated with your Best Practices Presentations) will be assigned during the semester. These projects will familiarize you with searching online academic databases through the library and with proper APA citation formatting. This knowledge will be useful in both parts (I and II) of the capstone. Together the library projects are worth 20% of your final grade.

### Group Oral Presentations:

Students will work in groups of up to four members to present best practices in the business world. Topics must be approved by the instructor. These presentations will be up to 15 minutes in length and will also require PowerPoint or Prezi (Approx 10 slides). The presentations will be delivered in class the two weeks prior to the final exam. The group presentation will be worth 15% of your final grade.

### Strategic Thinking/Decision Making Paper:

This assignment covers key elements of Critical Decision Making and Strategic Thinking discussed in class during the semester. You will explore these elements as they pertain to a scenario involving a complex decision. More detail will be given in class regarding this assignment and it is worth 15% of your final grade.

#### Exams

Exams cover material from the lecture and the textbook and together make up 30% of your course grade. Exam II is not cumulative.
