LCSC Administration Communications - Dr. Andy Hanson

- Requested an update on intramural sports and advisory recreation projects
 - No new updates from ASLCSC, but this is on the agenda for Thursday discussion.
 - Dr. Hanson noted that these programs are run by student fees, so any projects should be designed with student engagement in mind.
 - Dr. Hanson would like to see regular meetings with these groups at least once (or every other) month.
 - Points of contact: Brook Hens and Susan Steel.
- COVID-19 Update:
 - Yesterday (Monday, 21st) saw a high volume of calls about possible COVID cases, all related to the 3-day weekend.
 - Reminder to encourage students to follow safety measures/parameters put in place by the school and continue calling with any concerns about COVID-19 exposure.
- Enrollment Numbers:
 - The latest numbers are better than projected. Expected a 5% loss in enrollment but have only seen a 2% decrease, with an increase on the Coeur d'Alene campus.
- Administration would like continual feedback on how students are feeling about safety measures on campus, how classes are going, and good notes or critiques from students.
 - ASLCSC representatives noted that some students have settled into the new learning models, while others are continuing to face Zoom accessibility issues (such as moving from an in-person class to a remote class, then back to in-person all back-to-back, which is causing some frustration), as well as difficulties with inconsistency between classroom expectations for remote learning (such as requiring audio to be on at all times, cameras to be on at all times, or only offering limited remote learning opportunities, etc.).

September 22, 2020

- Administration is examining ways to make hot spots on campus for students who need a place to access remote learning for their "in-between" remote classes when they would otherwise be in-person the rest of the day.
 - Administration is especially interested in hearing if students are seeing unexpected changes to learning models set at beginning of semester, such as being told to come in person but now moving to remote learning exclusively.
- Q&A:
 - Senator Hill asked about COVID-19 confirmed cases and what the requirements are for moving to remote learning.
 - Dr. Hanson offered to walk the ASLCSC council through an exercise the Administration is using to identify where that marker is (as there are several variables to consider).
