Special Guest Speaker– April Christenson, FNP-C, ACHPN, LCSC Student Health Services.

My name is April Christenson. I work in Sam Glenn 205. Not employed by the College but by St. Joseph Regional Medical Center. A year ago the college approached St. Joseph Regional Medical Center about providing assistance to support the College's Health Care Office.

Previously, LCSC had a Health Care Office. Doug Steele oversees the student health office on the LCSC side. St. Joseph Regional Medical Center oversees the staffing of the office. April is very excited to manage the LCSC clinic. One of the missions of the St. Joseph Regional Medical Center is to bring healthcare to the people. Bringing health care to the LCSC students. The health office is also available to the Faculty/staff on campus. Current Hours:

Monday – Thursday: 8-5pm

Friday: 8-12pm

LCSC Student Health Services is a fully functioning clinic. Anything you would need to go to Urgent Care or a doctor for, they can do LCSC Student Health Services. Example: Blood draws, thyroid testing, urine testing, immunization – flu shot is now available, TBT testing. Any routine health management. Some staff and faculty have moved their primary provider to LCSC Student Health Services. As long as you work, even if you teach one credit or work one hour of work at LCSC, you are eligible to come to the office. If you transfer/or leave LC, you have 6 months to transfer.

Encourage students to be seen. You can be seen insurance or not. Financial aid applications are available through the hospital, if your students are making less than 30,000 a year, various fees can be waived including lab work or various test, including an MRI. Sometimes 100% has been offered, other waivers are available. LCSC Student Health Services is available pretty quickly. Typically able to see patients that day or the next day. LCSC Student Health Services offices goal is to cater to the entire LCSC population

40%+ is not on insurance so they are receiving full waivers. Some medications are not covered but will work hard to find affordable medications. If it costs more, works with Snake River Clinic downtown.

LCSC Student Health Services does not do x-rays here. Typically we would send you to St. Joes. Do not have a way to give IV fluids. Can do blood work promptly. LCSC referred X-rays to St. Joseph Regional Medical Center do not need appointments

April Christenson brought information cards that include lists of services and contact details. More cards are available at the LCSC Student Health Services or you can email her and request them.

LCSC Student Health Services are only available to active students, faculty, and staff. Does not provide services to the general public, outside of the college.

CDA students would need to make a trip to LC Campus if they need assistance. Offer assistance to LCSC @ CDA.

April Christenson was pleased to return to LCSC as she had previously been a student and worked on campus. April graduated from LC twice, 1998/2007. Later worked at the college, under the supervision of Andy Hanson, did recruitment for LCSC. Foundation scholarships.
