- I. Call to Order @ 3:15pm
- II. Approval of Faculty Association minutes from August 15, 2019: *Motion to approve by Eric Martin,* 2nd by Lynne Bidwell, Approved unanimously
- III. Treasury Report as of October 31, 2019
 - i. Benevolence = 4,822 To help faculty members in need.
 - ii. Local (Faculty Association) = \$4.427 -

⇒ Consider donating to Faculty Association; Benevolence Fund, etc.

- ⇒ Everyone is encouraged to contact the benevolence committee when they know of any faculty member in need. Some divisions are more proactive in requests than others.
- IV. Faculty Fund Survey Results
 - i. 60 faculty members participated in the survey.
 - I. Faculty overwhelming chose 'advocacy' as the number goal for the fund. Close to 70% of faculty member made this their first or second choice on the survey options.
 - ii. How will we move forward for advocacy?
 - I. Please email the faculty chair or senators with strategies and ideas on how to use the fund for types of advocacy. Suggestions mentioned at this meeting included,
 - I. using the funds to accompany the team that goes to Boise each year for higher ed week, should funds not be covered by administration.
 - II. Legislative CEC hearings we have never had a presence there but attending open sessions would be a good investment of time.
- V. Election of Faculty Secretary for the remainder of the year; Royal Toy has been nominated to fill the position left vacant earlier in the semester.
 - i. Motion to approve by Eric Martin, 2^{nd} by Harold Crook, Voice vote Approved unanimously one abstention
- VI. OER Policy Request has been made to reach out to the faculty associations of the other Idaho higher education institutions regarding the new OER policy.
 - i. III.U. Textbook and Instructional Material Affordability (10-2019) Beginning no later than Academic year 2021



- ii. Proposed Language: While we acknowledge the need to keep textbooks affordable for students, the LCSC faculty does not believe SBOE policy III U 2 A 6 is in our students' best interest, because experts in the field should determine the curriculum, which starts -- fundamentally -- with textbook selection.
- iii. Can this be discussed in Senate next month?
- iv. Comments on this very early draft varied:
 - I. A more strongly worded statement opposing the existing language would be preferable.
 - II. This is a good start
 - III. Are the State Board of education "experts in the field" we should change this language
 - IV. Better way to frame the way we share this to avoid OER, as it is still a choice...
 - V. Would it be appropriate for the Faculty Association to make a motion to support the Faculty Senate's direction?
 - VI. Move we support opposing the policy as is currently stated.

Motion made by Eric Martin, 2^{nd} Amy Camfield – 2 abstentions, motion passed.

- VII. Harold Crook Suggestion: Randall Brumfeld is gone now and moved to a new position. It may be helpful to communicate with Johnathan Lashley, who is the Associate Chief Academic Officer
- VIII. GenEd summit 2018 Faculty around the state have already presented their opinions. Clearly our advice as the general education experts was not heeded. Back this up with rationale Craft this language.
 - IX. Language from Chris Riggs, could we use that to draft the language.
 - X. Explain abstention Appropriation bill may have language about OER... this may need to be directed to the legislature rather than just SBE.
- XI. Encourage faculty who support to engage in this, but
- XII. If we use language that states how we can work within this, we admit defeat already.
- XIII. SBE promised this would not be put in policy, and now is, so there are trust and believability issues now.

Any ideas and language change proposals should be sent to the faculty chair to incorporate into any new draft.
