- Legacy Project Update
 - 2019-2020:
 - Walkthrough of SAC Building tomorrow to select a location for the Warrior Pantry donation station
 - Still working on available time with RCH Building
 - 2020-2021:
 - Countertops are being selected and finalized (will likely be laminate)
 - Physical Plant are making progress in choosing a contractor for paper towel dispensers
- Sodexo Talk with SAAC – Guest Speaker: Devon Caruso (LCSC Junior)
 - SAAC would like to improve food quality of Sodexo
 - They would like to evaluate the contract Sodexo has with Lewis-Clark State College
 - SAAC gathered information from students via a survey
 - Asked for student's perspective of quality (good, okay, bad, etc.)
 - Asked about availability and if students felt the hours met their needs (majority said no)
 - There has been student feedback to SAAC that Sodexo has not been providing the level of quality or options Sodexo provided
 - Quality definition: Nutrition content has not met the athletic division's requirements; students have provided feedback that the fruit and vegetables have either gone bad or are not ripe; the hours are not accessible to athletic students; Sodexo reportedly promised to provide after-hour snacks and meals but students have reported they were turned away when asking for these items
 - Correspondence that has already occurred:
 - SAAC has not yet had any communication with Sodexo
 - Communication attempts have been made to Sodexo with no returns
 - Tate Smith is planning on meeting with the SUB/CSL and Sodexo tomorrow; will look at working with the groups to determine next steps
