Dear all,

I have had a whirlwind three weeks in and out of Boise visiting with legislators. As you read last week, we have quite a road to travel, but are on our way and I am optimistic. On Wednesday, Feb. 4, at 2 p.m., Pacific, I'll join Sen. Cindy Carlson in presenting the name change bill ([Senate Bill 1234](#)) to the Senate Education Committee ([live streaming](#)). A huge thank you again to Sen. Carlson for being our sponsor in the Senate.

Spring is just around the corner! We've had a terrific launch to the semester and enrollment is holding strong. That said we cannot let up. Complacency is not a Warrior word! Maintaining our recruitment and retention efforts must continue to be priorities. As part of that, maintaining our position as accessible and affordable is key. And, with that in mind, we are just a month away from our March 1 priority financial aid and scholarship deadline for the coming year.

The March 1st deadline is important to both potential and current students. When students complete FAFSAs, their information is reviewed to determine eligibility for Pell Grants and student loans. When they submit by the March 1 priority deadline, they are also evaluated for eligibility for college work-study and the Federal Supplemental Educational Opportunity Grant (FSEOG).

March 1 is also LC State's and the State Board of Education's scholarship deadline. By close of business on this date, LC State's scholarship portal will be closed and students who accessed the portal before or by March 1 will be considered for institutionally held scholarships.

The State Board of Education March 1 deadline impacts Idaho Opportunity Scholarships (these scholarships are available for traditional students and adult learners who meet specific criteria). Students who currently have a State of Idaho Opportunity Scholarship must renew with the State Board by this deadline. Students who currently have LAUNCH funding support, should have their scholarship automatically renewed as long as they continue to meet the maintenance criteria.

As you know, many LC State students are the first in their family to attend college and are heavily dependent on financial aid to make it affordable. The more informed we all are, the better we can help and support our students, making pursuit of their education goals accessible and affordable!

Most projects on campus require IT involvement. If you are undergoing alterations in your area (e.g., updating a classroom or office), please inform IT of any projects to occur over summer by **March 1**. Likewise, if you need changes to the hardware or software in the computer labs for fall 2026 classes, the deadline to inform IT is **April 1**. Requests submitted after these deadlines cannot be guaranteed for summer completion.

### **State Budget Update:**

You may have read about the additional (meaning beyond the 3% current and FY27 reductions already implemented) 1% and 2% FY26 and FY27 budget reduction scenarios all state agencies had to submit by the end of last week. As was shared during the All-Campus Meeting, LC State navigated the 3% reductions by cutting the adjunct budget, eliminating some delayed hire positions as well as faculty development funds. The additional reductions, if they occur, would include restricting non-compliance travel and, depending on the scenario acted upon, eliminating 2-5 additional FTP in delayed hire positions. Additional information will be shared as it becomes available.
