



**Lewis-Clark State College/College of Western Idaho
Associate of Applied Science to Bachelor of Applied Science Degree Articulation
Agreement**

The College of Western Idaho (CWI) and Lewis-Clark State College (LCSC) enter into this articulation agreement to facilitate the transfer of the College of Western Idaho's AAS degrees to Lewis-Clark State College. Under the provisions of this agreement, CWI students may be granted admission into LCSC* with third year (junior) standing, conditional on having met the conditions contained within this agreement.

*Programs such as education, nursing, and social work require additional application processes. Admission to these programs is not guaranteed.

Purpose

The purpose of this agreement is to articulate the College of Western Idaho Associate of Applied Science (AAS).

Upon completion of the AAS degree at the College of Western Idaho, academic credit/courses taken at College of Western Idaho will be transferred to Lewis-Clark State College under the following conditions/restrictions:

- The student will NOT be core certified and will be required to meet his/her core requirements at LCSC.
- Up to forty (40) technical credits from CWI may be applied toward the Bachelor of Applied Science (BAS) at LCSC.
- The application of technical credit will take place after the student is admitted to the BAS program.
- A maximum of seventy (70) academic and technical credits total will be counted toward the baccalaureate degree.

For the purposes of this agreement, the student may select any edition of the Lewis-Clark State College catalog, provided that the catalog was published and was in force while the student was enrolled at Lewis-Clark State College and/or the College of Western Idaho, and provided that the catalog is no older than six (6) academic years at the time of graduation from Lewis-Clark State College.

Process

- College of Western Idaho will provide current AAS degree requirements to Lewis-Clark State College and notify LC of any degree requirement changes that occur.
- College of Western Idaho will provide advisement to College of Western Idaho students with Lewis-Clark State College available for questions and assistance related to transfer issues along with periodic training opportunities for will provide pre-transfer advising at the point the student attains 45 credits.
- Lewis-Clark State College staff will be available for questions and assistance related to transfer issues along with periodic training opportunities for College of Western Idaho advisors.
- Lewis-Clark State College will notify College of Western Idaho of any degree requirement changes that occur.
- Lewis-Clark State College will provide College of Western Idaho advisors and students with specific department/major pre-professional course requirements including course equivalency worksheets along with other, if applicable, department/major specific requirements.

Conditions

- Students must submit an official application to Lewis-Clark State College and provide LC with documentation (transcripts) proving successful completion of the AAS degree at College of Western Idaho.
- Non completion of the College of Western Idaho AAS degree program will void the provisions of this agreement.
- Completion of the AAS degree provides a guarantee transfer of credit to the university but does not guarantee completion of all lower division degree requirements.
- If specific prerequisites have not been met at College of Western Idaho, those prerequisites will need to be met prior to being accepted into the program/major.
- Attendance at another institution after completion of their College of Western Idaho degree and prior to start at Lewis-Clark State College will void the provisions of this agreement.
- Students must complete a minimum total 120 credits to graduate from Lewis-Clark State College with a bachelor degree. A minimum of 40 credits must be at the upper division level and 30 of the last 36 credits for graduation must be completed at Lewis-Clark State College.
- No tuition will be assessed for articulated credit.

Renewal, Revision, Termination

This agreement is effective as February 1, 2018 and will be reviewed for renewal every five (5) years. Either CWI or LCSC upon written notice to the other institution may request revision of this agreement. Either institution, at any time during its term, may terminate the agreement for reasons of noncompliance via written notice to the other institution. Termination notice shall not be given less than 60 days prior to the end of the current term of the agreement.
