#### Dear all.

It's finals week and I thought I would share an interesting bit of data. During our October State Board of Education annual update report, we shared outcome data associated with enrollment, retention and graduation rates. As you may recall from that presentation and this year's Presidential Priorities, our ongoing enrollment focus emphasizes *Inputs, Throughputs* and *Outputs*. With that in mind, I asked Institutional Research if they could determine the percentage of students who enrolled with us this fall that are still with us as we enter finals week. While this is <u>not</u> an official IPEDS retention rate (that annual rate is calculated only on first-time/full-time degree seeking students), it does provide us with a glimpse of the real-time impact of our various *throughput* efforts are having (i.e., the Academic Coaching Advising model and At-Risk Early Alert system; Handshake College-to-Career implementation; the Student Success Center one-stop with expanded tutoring services co-located with the food pantry in the Library; enhanced student engagement via our student involvement coordinator and the DoMore app implementation; expanded face-to-face and online counseling support services; and cohort and community building living learning communities). As of this message, we have 98% of our fall enrollees preparing for this week's finals. Well done, Warriors!

## **Data Management Process:**

In the evolving landscape of information security, LC State has implemented a new standard to meet audit requirements. All software, IT systems, and services that store or process data must now be reviewed and approved **before purchase** – this includes any system that handles sensitive, classified, public and institutional data. Please note that this review is required annually, even for items previously approved in past years. Departments must resubmit a <u>Software and System Request Form</u> each year to ensure continued compliance and data protection. To avoid delays, please plan ahead for any upcoming or auto-renewing subscriptions by submitting the form well in advance (we recommend one—two months prior to purchase). This allows our IT team sufficient time to complete the necessary security and compliance reviews and provide the required IT approval documentation for your p-card transaction or Jaggaer requisition. Your cooperation in meeting these audit requirements helps ensure LC State continues to operate securely and in full compliance.

#### **Evaluations:**

It's Performance Evaluation Time! The annual staff performance evaluation process has begun. Evaluation forms and the rating scale are available on the <a href="HRS website">HRS website</a> under the Performance Evaluations link. When completing evaluations, take time to fairly reflect on your employee's performance over the past year. Evaluations must be authentic, which means it is highly unlikely that everyone will receive the highest performance rating every time. The highest performance rating should recognize those who have truly gone above and beyond expectations and consistently demonstrated exceptional performance this past year. To support supervisors and employees through the process, HRS will be hosting Performance Evaluation Workshops in December and January for anyone who would like a refresher or have questions about completing their evaluations. Thank you for your thoughtful participation in this important process and for recognizing the great work of our LC employees! Please remember:

- Evaluations are due on or before Jan. 30, 2026.
- Use the Supervisory Evaluation Form for employees who supervise one or more benefit-eligible employees.
- Use the Non-Supervisory Evaluation Form for employees who do not supervise benefit-eligible staff.
- For employees who have been in their position six months or less, please complete an abbreviated evaluation and mark the "Special Evaluation" box under Section IV on the form.
